INTRODUCTION

This child labor guide has been developed to support the efforts of farm management to address the risks of child labor on their farms while taking into account their different operating contexts. It focuses on Rainforest Alliance certified crops such as coffee, cocoa, hazelnut and tea, however it can be used for other crops as well. All information can be used to inform training and awareness raising sessions, as you see fit.

We have used the term 'farm management" throughout the guide; this term refers to cooperatives, estates and trader-led groups. The term farmers refers to both female and male farmers and children refers to boys and girls under the age of 18.

The guide is designed to support farm management as they adopt and implement the [assess-and-address](#) system of human rights due diligence, in the 2020 Certification Program. This new, risk-based approach focuses on prevention, engagement, improvement, and incentivizing farmers and companies to tackle these issues rather than hiding them.

The guide contains the following modules, which are aligned with the Assess-and-address system, as well as three annexes and a Workbook of exercises. The Workbook includes the Risk Guidance, a library of risk questions, guidance and mitigation actions that is a practical resource for farm management, when developing action plans to prevent risk.
