

1. INTRODUCTION

The Rainforest Alliance Certification Program, based on the 2020 Sustainable Agriculture Standard, introduces several requirements for Certification Body (CB) personnel that will strengthen our assurance system but will need additional time and resources to be fully implemented. Therefore, the Rainforest Alliance authorizes the changes summarized in this policy, during the transition year. In addition, this document includes the minimum requirements CB Personnel must comply with to be authorized to provide certification services to their clients under the Rainforest Alliance 2020 Certification Program. The CB personnel requirements listed in this policy replace those of Chapter 2 of the Rules for CB personnel version 1.1.

Furthermore, this policy aims to shed light on frequently asked questions and support CB's in complying with Chapter 2: Rules for CB personnel, part of the Rules for CBs.

All changes and exceptions enclosed in this document are not retroactive and only come into force after its publication in December 2021.

3. OBJECTIVES

Communicate the changes authorized to Chapter 2: Rules for CB personnel of the Rules for CBs, version 1.1, and guide CBs on the implementation of said chapter.

4. TRANSITION YEAR EXCEPTIONS.

 The deadline to complete training on Social Auditing and ISO is extended from 30th of September 2021 to 30th June 2022. Additionally, for China, the Rainforest Alliance does accept certificates from the Certification and Accreditation Association (CCAA).



- Social Training duration for the approval of **Lead Auditor for Social Topics (L.A.S.T)** is reduced from 60 to **48 hours**. 40 hours must be reached during the transition year, i.e. completed by 30 June 2022 and the remaining 8 by **30th of June 2023**.
- As a result of the extension, the Rainforest Alliance will require all staff to follow the Rainforest Alliance Learning Network (RALN) online training on Chapter 5 by the 31st of December 2021. You can find the links below.
 - The modules DO NOT substitute the social audit training requirement, but rather are a way for CB personnel to gain knowledge on social topics during the transition year.
 - If the modules are not available in your preferred language and you are unable to follow the English version, then you are not obliged to follow said modules. You are asked to follow only those modules which you can understand. However, please keep a close eye as more modules become available in more languages on a regular basis.
 - CB personnel may conduct audits while they are completing the mentioned modules, provided they meet the corresponding approval requirements.

6. REGISTRATION

- All CB personnel must hold a Rainforest Alliance Learning Network (RALN) account before registering in the Rainforest Alliance Certification Platform (RACP). You may register here.
- CB personnel registered for the legacy UTZ and 2017 Rainforest Alliance programs may register under their current role, provided they meet the corresponding 2020 Rainforest Alliance Rules for CB personnel requirements. There is no need to start registration in a more junior role.

7. TRAINING COURSES REQUIREMENTS (EXTRACT FROM CHAPTER 2 OF THE RULES FOR CBS)

- 2.3 Training courses¹ referred to in the requirements may be held face-to-face or online.
- 2.4 If a duration is not stated, then the course shall have a minimum duration of 40 hours.
- 2.5 Every training course delivered will result in a certificate when successfully completed.
- **2.6** The certificate of the training course shall specify the course content and duration.
- **2.7** When requirements mention training in ISO, SAI, or any other standards and/or guidelines, the training shall cover the latest edition of the referenced document (including any amendments).
- **2.8** ISO Lead Auditor training courses shall cover applicable standards on quality auditing, auditing techniques, the focus of the audits (professional behavior and communication), reporting, and it shall also include a practical case study.

8. CB PERSONNEL APPROVAL REQUIREMENTS

Rules on the requirements for all personnel (extract from Chapter 2 of the Rules for CBs)

- 2.1.1 A CB structure shall consist at minimum of a scheme manager, certifier, database administrator, lead auditor, and CB instructor.
- **2.1.2** All CB Personnel roles may be carried out by hired workers, independent contractors, and consultants provided they meet the requirements set for the corresponding role and scope.
- 2.1.3 All CB personnel involved shall be assigned to one or more roles.
- 2.1.4 All CB Audit Team and Certifiers shall meet at least once a year (virtually or physically) to carry out calibration activities or sessions
- **2.2.1** CB personnel shall meet the corresponding approval requirements to be eligible for the Rainforest Alliance Certification Program CB personnel approval.
- **2.2.2** CB personnel shall always meet the List of Requirements for all Personnel.

Requirements for all personnel

These are good core auditing practices and are formulated as compliance criteria (yes/no) applicable to all roles. These are independent of CB scope requests or approvals. Rainforest Alliance's CB training defines **training** as all capacity-building activities designed on clear learning objectives that aim to bridge gaps in knowledge, skills, and/or attitudes to ensure CB personnel have consistent levels of competence and understanding of the Rainforest Alliance Certification Program.

- Unless otherwise instructed, all training sessions may be developed and provided internally (in-house) by an approved CB instructor. CB personnel or an external training provider with relevant experience may also develop and deliver training, provided they are supervised by the CB instructor.
- Training hours can be reached by combining one or more training sessions. e.g. CB personnel can follow two courses of 20 hours each and one training of 8 hours to reach the 48-hour training requirement.
- A single audit may be taken into consideration to comply with different audit experience requirements provided the audit scope is relevant for all corresponding topics such as social, G.A.P./organic, supply chain, and environmental audit experience.

Audit team categories

The audit team refers to the CB personnel who perform audits for a CB (as employees or independent contractors). The categories have a sequential logic, each building upon the previous category.

2.2.1 For CB personnel to proceed to the next category, they shall comply and remain compliant with the previous category requirements. This does not apply to Technical Experts who provide services and support to the audit team.
