When implementing the Standard and preparing for the 2024 audit, the Certificate Holder (and Certification Body) shall use the LW benchmark 'For 2023 payroll data'.

Unless otherwise stated, benchmarks are indicated in local currency, in gross wage per month.

Countries in Table 2, for which no Living Wage (LW) benchmark is yet available, the Living Wage requirements still apply. When completing the Salary Matrix tool, the Certificate Holder shall use the applicable wage i.e., whichever is highest out of the minimum wage or CBA.
